# Brandon Walker Memorial Fundraiser Walleye Fishing Tournament

## Official RULES AND REGULATIONS

### PARTICIPATION AND ELIGIBILITY

1. The registration deadline will be 7:00a.m. June 24, 2017
2. Entry fee refunds will be made if proper notification is made to tournament chairmen prior to June 24, 2017. A \$10.00 service charge will be retained regardless of cancellation date.

### BOATS AND EQUIPMENT

1. All boaters will be required to meet USCG safety regulations.
2. Boats may be equipped with electric positioning or trolling motors.
3. Electronic and electrical depth finders, thermometers, oxygen meters ect. , are allowed.

### TACKLE AND EQUIPMENT

1. Michigan regulations will apply to all fishing methods and equipment.
2. All fish must be caught live and in a conventional sporting manner on hook and line during the hours of the fishing tournament.
3. Each boat will be allowed a maximum of Nine(9) lines in the water at any time.
4. No binoculars or cameras with telephoto lens will be allowed in contestant boats.
5. Teams are responsible for picking up and returning **BOAT BOARDS.**

### PERMITTED FISHING WATERS

1. The Karn Weadock hot ponds are **NON-FISHABLE.**
2. All boats will be inspected in the water. Linwood Bch. Marina will be the official launch site. Failure to allow inspection will disqualify contestants.
3. Boats will be allowed to travel a direct route from their mooring to the designated inspection site.

### FISHING HOURS AND STARTING TIMES

1. The tournament fishing hours will be 9:00a.m.-3:00p.m.
2. Each team will be allowed a maximum six (6) hours of fishing time including travel time.
3. Contestants who return later than their assigned return time will be penalized one (1) pound per minute from the total weight. Any team more than fifteen (15) minutes late will be disqualified.

### FISH SIZE AND LIMITS

1. The minimum length of any eligible fish is **thirteen(13)** inches in length.
2. The tournament limit is five (5) fish per person.
3. Dead fish **CANNOT** returned to the water.

### WEIGH-IN

1. A certified scale for weigh-in will be available throughout the fishing day.
2. Each team is responsible for their own catch. Under no circumstances may anyone other than the contestants handle or touch the catch until it has been presented to the weighing officials.
3. An unloading area will be designated immediately in front of the weigh-in area.
4. All boats must land at the launch site only or face disqualification.
5. Each team will be allowed to weigh-in a maximum five (5) fish. At the discretion of the weighing official, a gill may be cut to establish a live or dead fish.

### BOAT IDENTIFICATION AND PATROLLING

1. All boats must be identified as contestant boats and permit boarding by the patrolling boats.

### SPIRIT OF THE RULE

1. All rules have "loopholes". It is the intention of the sponsors to provide an honest sportsman-like tournament. All questions or problems are to be referred to the tournament directors who will have sole jurisdiction in determining the application of the rules.
2. Protests must be accompanied by a \$100.00 fee to be refunded in the event of the protest being upheld. All protest must be made within one (1) hour of the end of the tournament fishing hours.
3. Any disqualification will result in forfeiture of the entry fee.
